## **Pricing Schedule Effective 10/1/11**

In order for us to continue to deliver the clean and safe range that you have come to expect, we are forced to formalize certain business practices. One of these practices is to standardize guest instructor use-rates for the facility.

We are proud of the fact that our facility is kept clean and safe through aggressive air system and range equipment maintenance. As you can well imagine, this translates into direct and unavoidable expenses. We have become known and respected in the area for our willingness to open our facility to other instructors (competitors), for the good of the sport and with the genuine desire to increase the level of professionalism for all who work in an armed capacity.

We appreciate the fact that you, like ourselves, must control operational costs, both direct and indirect, in order to remain in business. For this reason we anticipate your understanding and cooperation with the following conditions and pricing schedules as it pertains to your use of our facilities.

- Guest Instructors who wish to use the range and/or classroom **MUST make arrangements a minimum of 2 week in advance**. To do this you must speak directly with the Operations Manager.
- "No Show" classes/instructors will result in a penalty charge of \$100.00
- Range management **MUST** approve all non-standard training curriculums in advance.
- Guest Instructors are required to be present at least one half hour prior to class start time, so they may greet and direct their students. (This also allows us to meet any last minute needs you may have.)
- **Guest Instructors may only have one lane per instructor.**
- Payment for facility use must be made at time of use unless prior arrangements are made.
- Any use of the facility during non business hours needs a minimum of 3 weeks advanced notice and must be approved by the Operations Manager. Pricing to be discussed at scheduling of date.

**Usage Fees: (Fee structure valid during normal business hours only)**

**Range Use Only:**

Flat rate of \$25 per student (2 hours max)

Shotgun/Long Gun = additional \$15 per student (2 hours max)

**Classroom Use Only:**

Flat rate of \$30 per student (maximum 7 hours per day)

Minimum use fee of \$125 applies

**Classroom and Range Use Combined:**

Classroom & Range Use: Flat Rate - \$40/person (based on Maximum 7 hour Classroom & 2 hour Range) Minimum use fee of \$175 applies

Taxes: If applicable – are extra

## Guest Instructor Range Use Agreement for Bridgeport Shooting Range LLC

As a guest instructor, being allowed to use the Bridgeport Shooting Range, I agree to the following criteria and schedule:

1. A copy(s) of my current instructor certification shall be provided, and it will be my responsibility to ensure that I maintain a current certification.
2. All training and/or supervision of shooting exercises shall be conducted by myself and/or my designated representative who shall be certified as an instructor and who shall comply with #1 above.
3. Range and/or the classroom must be requested in writing via email no later than 2 weeks prior to the use date.
4. Following acknowledged receipt of request – a “no show” or cancellation of the range/classroom will result in a cancellation fee of \$100 for classroom use only or \$150 for classroom and range, being charged. A valid current credit card must be on file.
5. All Shooting/educational materials and supplies to be provided by the guest instructor, unless prior arrangements are made.
6. All range safety rules/regulations/policies and the quest instructor and student of that instructor shall adhere to procedures. Bridgeport Shooting Range Release Hold Harmless form will be filled out by all guest instructors per calendar year and by all students. You may find this form on line at [www.bridgeportshootingrange.com/release](http://www.bridgeportshootingrange.com/release). You are welcome to print this out before hand and have your students fill them out prior to coming to class. Please also have them bring a copy of their photo ID's.
7. Guest instructors accept and acknowledge responsibility for the safety and well being of all their students while in attendance at the facility.
8. In the event of a dispute, it is understood that the decision of management (Bridgeport Shooting Range, LLC or APC, Inc), will be final and binding.
